Guido Bortoluzzi is a Full Professor of Innovation Management and Entrepreneurship at the Department of Economics, Management, Mathematics and Statistics “Bruno de Finetti” at the University of Trieste, Italy. His research interests focus on business modelling, creativity, innovation management, and entrepreneurship. He has published extensively in high-impact journals like Harvard Business Review (German edition), Technovation, Journal of Business Research, European Management Journal, and International Marketing Review. In addition to his teaching and research responsibilities, Guido Bortoluzzi is Coordinator of the PhD programme in Circular Economy at the University of Trieste.

Selma Kadic-Maglajlic is an Associate Professor of Marketing at Copenhagen Business School, Denmark. She earned her Ph.D. in 2013 from the University of Ljubljana, an MBA from the University of Zagreb, and a BSc in Marketing from the University of Sarajevo. Her research focuses on personal selling, sales management, interpersonal influence, emotions, and ethics in selling. She has published in journals such as Journal of Business Ethics and Journal of Business Research. Kadic-Maglajlic has also been a visiting lecturer at several international institutions and has significant experience in securing research funding and managing accreditation processes.

Giacinta Cestone is a Professor of Finance and the Director of the [PhD Programme in Finance](#) at Bayes Business School in London. In her research she investigates the interaction between corporate finance, labor and product markets. She has published her research in leading academic journals, contributing significantly to the understanding of how ownership and financial structure shape product and labor markets. He holds a Ph.D. in Mathematics Applied to Decisions in Economics and Finance from the University of Trieste.

His research interests include the fair valuation of life insurance guarantees, optimal insurance contracts, and mortality forecasting. Millosovich has published extensively in high-impact journals and is recognized for his contributions to actuarial science and finance theory.

Ludovico Carrino is an Assistant Professor at the University of Trieste. His research focuses on health economics, aging, and social policy. Carrino has published in several international journals and is known for his work on the economic implications of aging populations and the effectiveness of social policies in healthcare systems.
